## RESIDENTIAL AND MAILING ADDRESSES

Please note that we are required to collect a residential address/registered office address for the account holder(s).

## ATTORNEYS

If you are signing under power of attorney, please provide identification and attach a certified copy of the power of attorney and specimen signature(s) of the attorney(s) if not displayed on the document.

	Company, Incorporated Association or Body	Name of Company, Incorporated Association or other Body. Please provide the Tax File Number (TFN) and ABN/ACN of the Company, Incorporated Association or other Body if available
	Trust or other Entity	Please supply full name of all Trustees, the Family Trust, Superannuation Fund, Business Name or Unincorporated Association. Please provide the entity's TFN or reason for exemption if available
<b>Account Designation</b>	eg. <Citizen Superannuation Fund A/c>, <Estate of the Late Agnes Sample A/c>, <Citizen Family A/c>	
<b>Residential Address/ Registered Office</b>	Individuals/Companies	A residential address or registered office address must be quoted. A separate mailing or PO Box address may be supplied

<b>Execution by the Applicant</b>	Individuals	The individual in whose name the account is opened should sign
	Joint Application	Application(s) should be signed by all persons who will be deemed joint tenants

	Deceased Estate	Executors of the Estate
	Unincorporated Body	Appointed Officers must sign. The officers might be titled President, Chairman, Secretary, Treasurer etc. Officers must specify their title
<b>Execution by the Applicant</b>	Companies	<p>These accounts must have two signatures, with the officers stating the office held as 'Director' or 'Secretary' (there must be one Director)</p> <p><b>OR</b> one signature with the officer signing stating the office held as 'Sole Director and Sole Company Secretary'</p> <p><b>OR</b> two signatures without the office stated, but with the company seal affixed</p>
<b>Deed of Guarantee and Indemnity</b>	Companies	Guarantee and Indemnity must be completed by a Director/Guarantor and witnessed
